 - b. Water, Wastewater, Drainage and Paving Improvements for Hilltop Southwest.
6. Deeds, easements and assignment of or acceptance of assignment of an easement, consents to encroachment, requests for service or utility commitment letters.
7. Operations matters, including operation of District facilities, billings, repairs, maintenance, and adopt Amended Rate Order, if appropriate.
8. Water and wastewater agreements, and Joint Facilities Agreement with Travis County Improvement District No. 1.
9. Adopt Resolution Establishing Standards for Recreational Facilities to be developed by the District.
10. Receive public comments on Park Plan.
11. Adopt Park Plan.

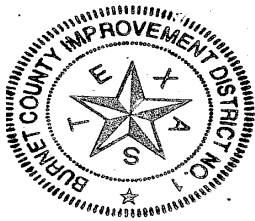
