## NOTICE OF PUBLIC HEARING

Pursuant to Sections 84.003-84-004 and 152.905, Texas Local Government Code, a public hearing will be held on August 20, 2025 at 8:00 a.m. in District Courtroom #2, Burnet County Courthouse Annex North, 1701 E. Polk Street (Hwy 29 East), Burnet, Texas before the undersigned, Judges of the 33<sup>rd</sup> and 424<sup>th</sup> Judicial District Court of Burnet County for the following purposes:

- 1. Appointment of Burnet County Auditor;
- 2. Re-Appointment of Llano County Auditor;
- 3. Re-Appointment of Blanco County Auditor;
