- -Joppa Bridge, going down the path to get it repaired

- -There is a 2 to 3 year restoration plan, the first update will be the roof and windows

- -Untold Marker, writeup is being worked on. Minimum of five pages on the history of the cemetery. To be submitted to THC for review.

- -Credit Card reader has been purchased, need assistance in getting set up for use on Saturday. Doak and Damon will help with set up.
- -Consider purchase of bags for future book sales, or use Burnet swag bags.

Finances

New Business:

Florence announced on April 26th at 11:00 AM the Library will have a Grand Re-Opening of the Elizabeth Van Gorkom Genealogical Research Center. This is the Burnet County repository for local and family history.

Jane recommended a field trip sometime in October to the Falls on the Colorado Museum. Currently under construction, opening up the second floor to preserve and share with the public, per Amanda.

Discussion about updating the Burnet County family histories, information was submitted by families. Darryl Debo authored Burnet County History: A TexasPioneer History, 1847-1979, a two volume set.
